#### SURVEYOR'S CERTIFICATE

I, ARNOLD R. KEGEL, A REGISTERED PROFESSIONAL ENGINEER, BEING FIRST DULY SWORN, DISPOSE AND SAY THAT I HAVE CORRECTLY SUBDIVIDED, SURVEYED, AND MARKED WITH LEGAL MONUMENTS THE LANDS REPRESENTED ON THIS PLAT OF CROOKED RIVER RANCH NO. 4, A SUBDIVISION TO DESCHUTES COUNTY, OREGON, LOCATED IN PORTIONS OF SECTIONS I AND 2, TOWNSHIP 14 SOUTH, RANGE IZ EAST, W. THE BASIS OF BEARING FOR THIS SURVEY IS THE SOUTH OREGON LAMBERT COORDINATE SYSTEM UTILIZING U.S.C. AND G.S. TRIANGULATION STATIONS "BUG FALLS" AND "JUNI" FOR REFERENCE.

THE INITIAL POINT OF THIS SURVEY IS THAT POINT ON THE JEFFERSON - DESCHUTES COUNTY LINE (ALSO TOWNSHIP LINE ) ESTABLISHED DURING THE UNITED STATES SURVEY OF JULY 1871 BY THE GENERAL LAND OFFICE AS THE ONE-QUARTER SECTION CORNER COMMON TO SECTION 35, TOWNSHIP 13 SOUTH, RANGE IZ EAST AND SECTION 2, TOWNSHIP 14 SOUTH, RANGE IZ EAST, W.M. THE SURVEY OF CROOKED RIYER RANCH NO. 4 NECESSITATED FURTHER RECOVERY AND RETRACEMENT OF THE GENERAL LAND OFFICE SURVEY OF SECTIONS I AND 2, TOWNSHIP 14 SOUTH, RANGE 12 EAST, W.M., AS FOLLOWS:

CONTINUING THE SURVEY AT THE PREVIOUSLY LOCATED SOUTHEAST COMMER OF GOVERNMENT LOT I IN SECTION I, I THEN CONTINUED SOUTH O' 38'29" EAST ALONG THE THIRD GLIDE MERIDIAN 1342.50 FEET TO THE EAST ONE-QUARTER COMMER FOR SECTION I, MARKED BY AN EXISTING WOODEN POST HEWED ON THE NORTH FACE AT THE COMMER OF TWO FENCES WHICH BEAR SOUTH AND EAST. I FOUND IMMEDIATELY WEST OF POST A LOOSE STONE 20x 10x8 Ins. LYING ON GROUND SURFACE AS A WITNESS, ASSUMED TO BE ORIGINAL COMMER MONUMENT AS DESCRIBED BY THE SURVEYOR GENERAL. THIS POSITION OF THE POST IS RECOGNIZED AS THE CORNER BY ADJACENT LAND OWNERS. WITH THE PERMISSION OF THE LAND OWNER I REMOVED THE CORNER POST AND SET A CONCRETE MONUMENT AFFIXED WITH A BRASS CAP AND MARKED FOR LOCATION. I THEN REPLANTED THE FENCE POST IMMEDIATELY SOUTH OF THE NEW MONUMENT

WHERE I SET A STANDARD CONCRETE MONUMENT BY DOUBLE PROPORTIONATE MEASUREMENT, AFFIXED WITH A BRASS CAP MARKED FOR LOCATION. SAID CORNER BEARS NORTH 0°25'00" EAST 2642.53 FEET FROM THE ONE-QUARTER COMMEN COMMON TO SECTIONS IJ AND 12 WHERE I POUND A SCRIBED STAKE IN A ROCK MOUND . I THEN TRAVELED NORTH 0° 23'39" EAST ON THE SECTION LINE COMMON TO SECTIONS I AND 2 A DISTANCE OF 2642.52 FEET TO THE ONE QUARTER COMMEN COMMON TO SECTIONS I AND 2 WHERE I SET A STANDARD CONCRETE MONUMENT BY SINGLE PROPORTIONATE MEASUREMENT ON THE SOUTH LINE OF THE PLAT OF CROOKED RIVER RANCH NO. 4 AFFIXED WITH A BRASS CAP AND MARKED FOR LOCATION, HAVING FOUND NO EVIDENCE OF THE ORIGINAL CORNER MONUMENT OR ACCESSORIES. (THIS CORNER WAS PREVIOUSLY DESCRIBED IN THE ABOVE BOUNDARY SURVEY OF CROOKED RIVER RANCH NO. 4 ). THENCE RETURNING TO THE CONNER COMMON TO SECTIONS 1, 2, 11 AND 12, TOWNSHIP 14 SOUTH, RANGE 12 EAST, I THEN TRAVELED NORTH 67 40'40" WEST ALONG THE SOUTH LINE OF SECTION 2 A DISTANCE OF 2654.80 FEET TO THE REMAINS OF AN OLD SCRIBED STAKE IN THE CENTER OF A ROCK MOUND MARKING THE ONE QUARTER SECTION CORNER COMMON TO SECTIONS 2 AND II WHERE I SET A STANDARD CONCRETE MONUMENT AFFIXED WITH A BRASS CAP AND MARKED FOR LOCATION. THENCE I CONTINUED NORTH 87º 19' 27" WEST 2641.99 FEET TO AN EXISTING ROCK MOUND WITH ONE BEARING TREE AS DESCRIBED BY THE SURVEYOR GENERAL AND A ONE - INCH IRON PIPE ( WHICH I REMOVED ) MARKING THE SECTION CORNER COMMON TO SECTIONS 2,3, 10 AND II. TO SET THE EXTERNAL BOUNDARY OF THE PLAT OF CROOKED RIVER RANCH NO. 4.

ALL LOT CORNERS ARE MARKED WITH 1/2 × 18 INS. IRON ROD EXTENDING 3 INS. ABOVE THE GROUND WITH 48 IN. HIGH WOODEN WITHESS STAKES. ALL ANGLE POINTS ON THE EXTERNAL BOUNDARY LINE ARE MARKED WITH 5/8 × 18 INS. IRON ROD EXTENDING 3 INS. ABOVE THE GROUND.





THE OBLIGATION FOR THE COST OF REMOVAL OF SNOW FROM AND THE MAINTAINING OF ALL ROADS, STREETS, AVENUES, AND PLACES WITHIN THIS PLAT SHALL BE THE RESPONSIBILITY OF THE ASSOCIATION, WHICH SHALL KEEP THE ROADS IN GOOD REPAIR AND SHALL RENDER THEM PASSABLE AT ALL TIMES. SAID MAINTENANCE SHALL BE CONDUCTED WITH FUNDS OF THE ASSOCIATION OBTAINED FROM ITS MEMBERS AND SHALL BE AT NO COST TO THE COUNTY.

IN THE EVENT THAT ANY OF THE OWNERS OF ANY OF THE LOTS OF THIS PLAT OR ADDITIONAL PLATS OR SUBDIVISIONS SHALL PETITION THE COUNTY COURT TO INCLUDE ROADS IN THE COUNTY ROAD SYSTEM. IT IS UNDERSTOOD THAT THE ASSOCIATION SHALL FULLY DEVELOP THE ROAD SYSTEM TO ROAD STANDARDS OF DESCHUTES COUNTY AND THAT ALL CONSTRUCTION SHALL BE FREE OF LIENS. COSTS AND OTHER LIABILITIES AND OBLIGATIONS. ACCEPTANCE IS AT EXCLUSIVE OPINION OF COUNTY COURT.

TRAIL EASEMENT

A HON-EXCLUSIVE EASEMENT IS HEREBY GRANTED TO THE ASSOCIATION FOR THE BENEFIT OF OWNERS OF ALL LOTS OF THIS OR ANY ADDITIONAL PLATS OF CROOKED RIVER RANCH, THEIR INVITEES AND LICENSEES. AND OTHER ASSOCIATION MEMBERS, FOR PURPOSES OF INGRESS AND EGRESS OVER, ACROSS AND ALONG THE REAR AND SIDELINES OF THOSE LOTS AS SHOWN ON THE FACE OF THE PLAT AND IDENTIFIED THEREON AS "RIDING & WALKING TRAILS". THIS EASEMENT SHALL BE FOR PURPOSES OF (1) RIDING AND WALKING TRAILS (2) UTILITIES. THE USE OF MOTORIZED VEHICLES IS EXPRESSLY PROHIBITED WITH EXCEPTION OF EMERGENCY EQUIPMENT OF PROTECTION, MEDICAL, OR FIREFIGHTING AGENCIES ON SUCH TERMS AND CONDITIONS AS MAY BE DEEMED ADVISABLE.

BUILDING RESTRICTIONS

ALL BUILDING PLANS FOR STRUCTURES TO BE BUILT IN THIS PLAT MUST BE SUBMITTED TO AND RECEIVE APPROVAL FROM THE ARCHITECTURAL CONTROL COMMITTEE OF THE ASSOCIATION. PARTICULAR EMPHASIS IS PLACED UPON THE TYPE OF STRUCTURE, SETBACKS, COMPATIBILITY AND SPECIAL CONSIDERATION FOR METHODS OF SEWAGE DISPOSAL.

SANITATION RESTRICTIONS

PHYSICAL CONDITIONS WITHIN THIS PLAT REQUIRE SPECIAL CONSIDERATION ON THE PART OF THE LOT OWNER IN FORMULATING A TOTAL BUILDING PLAN THAT INCLUDES A SATISFACTORY METHOD OF SEWAGE DISPOSAL. IN ORDER TO AID IN THIS CONSIDERATION, THE OWNER SHALL SUBMIT HIS PLAN TO THE AACHITECTURAL CONTROL COMMITTEE FOR REVIEW AND CONCURRENCE PRIOR TO SUBMITTAL TO THE COUNTY AUTHORITIES. THE COMMITTEE RESERVES THE RIGHT TO REJECT THE PLAN AND TO PREVENT CONSTRUCTION IF THE PLAN DOES NOT MEET CRITERIA FOR PREVENTION OF A PUBLIC HEALTH HAZARD OR POSSIBILITY OF A NUISANCE.



ALL STRUCTURES TO BE SETBACK SO FEET FROM FRONT PROPERTY LINE.


