

### MERIDIAN

THE BASIS OF BEAZING FOR THIS SURVEY IS THE SOUTH OREGON LAMBERT COORDINATE SYSTEM. UTILIZING U.S.C.&G.S. TRIANGULATION STATIONS "JUNI", "GENEVA", "SQUAW MOUTH" AND "PENINSULA NO. 2" FOR REFERENCE.

### MONUMENTATION

SUBDIVISION CORNERS AND EXTERIOR ANGLE POINTS ARE MARKED WITH CONCRETE MONUMENTS WITH LEAD PLUGS AS DESCRIBED. ROAD CENTERLINE CONTROL AT INTERSECTIONS AND POINTS OF CURVATURE ARE MARKED WITH 5/8 INCH IRON ROD BURIED 12 INCHES BELOW SUBGRADE AS SHOWN. LOT CORNERS ARE MARKED WITH 1/2 INCH IRON ROD EXTENDING 3 INCHES ABOVE GROUND SURFACE AND WITHESSED WITH YZ X 4 X 48 INCH PAINTED STAKES.

### INITIAL POINT

THE INITIAL POINT OF THIS SURVEY IS THE CENTER NORTH / 16 CORNER OF SECTION 8, TOWNSHIP 13 SOUTH, RANGE 12 EAST, WILLAMETTE MERIDIAN, (BEING ALSO THE SOUTHEAST CORNER OF THE NE 1/4 OF THE NW 1/4 OF SAID SECTION 8) WHICH IS A STANDARD CONCRETE MONUMENT AS DESCRIBED IN THE PLAT OF CROOKED RIVER RANCH NO. 10, AS RECORDED IN VOLUME 4 OF PLATS, PAGES 27 THROUGH 38, RECORDS OF JEFFERSON COUNTY, OREGON.

# CROOKED RIVER RANCH NO. 13 JEFFERSON COUNTY, OREGON

I SCRIBED THE BRASS CAP IN SAID MONUMENT TO READ "INITIAL POINT CRR NO. 13. 1977" CN 1/16. SAID CORNER BEARS SOUTHO 30'10" WEST A DISTANCE OF 1331.65 FEET FROM THE ONE-QUARTER CORNER COMMONTO SECTIONS 5 AND 8, TOWNSHIP 13 SOUTH, RANGE 12 EAST, W.M. THE COORDINATES OF THIS POINT ARE NORTH 1,020, 084.60 AND EAST 1,785,822.89, SOUTH OREGON LAMBERT GRID.

### LEGAL DESCRIPTION OF PLAT BOUNDARY

BEGINNING AT THE SOUTHEAST CORNER OF THE NEI/4 OF THE NW 1/4 OF SECTION 8, TOWNSHIP 13 South, RANGE 12 EAST, W.M., SAID CORNER BEING THE INITIAL POINT OF THIS SURVEY; THENCE NORTH 89°30'10" WEST FOR 1317.32 FEET TO THE SOUTHWEST CORNER OF SAID NE 4 OF THE NW 4; THENCE NORTH 0°42'47" EAST FOR 1331.80 FEET TO THE NORTHWEST CORNER OF SAID NE 1/4 OF THE NW 1/4, SAID CORNER BEING ALSO THE SOUTHWEST CORNER OF THE PLAT OF CROOKED RIVER RANCH NO. 11, AS RECORDED IN VOLUME 4 OF PLATS, PAGES 20 THROUGH 26, RECORDS OF THE CLERK OF JEFFERSON COUNTY, ÓREGON; THENCE SOUTH 89°29'48" EAST ALONG THE SOUTH BOUNDARY OF SAID PLAT FOR 1312.43 FEET TO THE NORTH ONE-QUARTER COMMON TO SECTIONS 5 AND 8, SAID CORNER BEING ALSO THE NORTHWEST CORNER OF THE PLAT OF CROOKED RIVER RANCH NO. 10; THENCE SOUTH 0°10'30" WEST ALONG THE WEST BOUNDARY OF SAID PLAT OF CROOKED RIVER RANCH NO.10 FOR 1331. 65 FEET TO THE INITIAL POINT OF THIS SURVEY.

#### **GENERAL**

EACH PURCHASER OF LOTS IN THIS PLAT IS REQUIRED TO RETAIN ACTIVE MEMBERSHIP IN THE CROOKED RIVER RANCHCLUB AND MAINTENANCE ASSOCIATION, A NON PROFIT CORPORATION, AND IS THEREBY SUBJECT TO ALL CONDITIONS, COVENANTS, RESTRICTIONS, RULES AND REGULATIONS AS SET FORTH IN COMPLETE ASSOCIATION DOCUMENTS FILED IN VOLUME \_PAGES\_\_\_\_THROUGH\_\_\_, RECORDS OF THE CLERK OF JEFFERSON COUNTY, OREGON.

### ROAD MAINTENANCE

OBLIGATION FOR ROAD MAINTENANCE RESTS WITH THE ASSOCIATION USING FUNDS COLLECTED FROM ITS MEMBERS AT NO COST TO THE COUNTY. IN THE EVENT THAT ANY OF THE OWNERS OF LOTS WITHIN THIS PLAT OR OTHER DIVISIONS OF CROOKED RIVER RANCH SHALL PETITION THE COUNTY COURT TO INCLUDE ROADS IN THE COUNTY ROAD SYSTEM, IT IS UNDERSTOOD THAT THE ASSOCIATION SHALL FULLY DEVELOP THE ROAD SYSTEM TO ROAD STANDARDS OF JEFFERSON COUNTY AND THAT ALL CONSTRUCTION SHALL BE FREE OF LIENS, COSTS AND OTHER LIABILITIES AND OBLIGATIONS. ACCEPTANCE SHALL BE AT EXCLUSIVE OPTION OF THE COUNTY COURT.

### SEWAGE DISPOSAL

EACH LOT HAS AN ACCEPTABLE SEWAGE DISPOSAL SITE AS REVIEWED AND APPROVED BY THE OREGON DEPARTMENT OF ENVIRONMENTAL QUALITY AND ITS AGENT, JEFFERSON COUNTY HEALTH DEPARTMENT. RESULTS ARE ON FILE WITH THE JEFFERSON COUNTY HEALTH DEPARTMENT. TEST LOCATIONS ARE SHOWN ON THIS PLAT. UTILITY EASEMENT
