
SURVEYOR'S CERTIFICATE

I, ARNOLD R. KEGEL, A REGISTERED PROFESSIONAL ENGINEER AND LAND SURVEYOR, BEING FIRST DULY SWORN, DISPOSE AND SAY THAT I HAVE CORRECTLY SUBDIVIDED, SURVEYED AND MARKED WITH LEGAL MONUMENTS THE LANDS REPRESENTED UPON THIS PLAT OF CROOKED RIVER RANCH NO. 16, A SUBDIVISION OF JEFFERSON COUNTY, OREGON, LOCATED IN PORTIONS OF SECTIONS 13, 14, 23 AND 24, TOWNSHIP 13 SOUTH, RANGE 12 EAST, WILLAMETTE MERIDIAN.

THE BASIS OF BEARING FOR THIS SURVEY IS THE SOUTH OREGON LAMBERT COORDINATE SYSTEM UTILIZING FOR REFERENCE, U.S.C. & G.S. TRIANGULATION STATIONS OF BIG FALLS, JUNI AND PENINSULA NO. 2.

MONUMENTATION

UNLESS OTHERWISE INDIGATED ON THE SUBDIVISION MAP, THE FOLLOWING MONUMENTS WERE USED IN THIS SURVEY:

SUBDIVISION CORNERS ARE MARKED WITH SCRIBED BRASS CAPS
SET IN PREFORMED CONCRETE MONUMENTS OR POURED BASES.
PLAT BOUNDARIES ARE MARKED WITH 5/8 INCH DIAMETER IRON ROD.
ROAD CENTERLINE CONTROL IS MARKED AT INTERSECTIONS, POINTS
OF CURVATURE OR POINTS OF INTERSECTION WITH 5/8 INCH
DIAMETER ROD BURIED I2 INCHES BELOW SUBGRADE.
LOT CORNERS ARE MARKED WITH 1/2 INCH DIAMETER IRON ROD
EXTENDING 3 INCHES ABOVE GROUND SURFACE AND WITNESSED
BY 2 * 2 * 24 INCH PAINTED STAKES.

COMMENCEMENT POINT

I COMMENCE THIS SURVEY AT THE ONE-QUARTER CORNER COMMON TO SECTIONS 14 AND 23, TOWNSHIP 13 SOUTH, RANGE 12 EAST, W. M., A 5/8 INCH DIAMETER IRON ROD WITNESSED BY THE ORIGINAL MARKED STONE AND ONE BEARING TREE AS DESCRIBED IN THE SURVEY OF CROOKED RIVER RANCH NO. 3 AS DESCRIBED IN VOLUME 3 OF PLATS, PAGES 1 - 12, RECORDS OF THE CLERK OF JEFFERSON COUNTY, OREGON. COORDINATES OF THIS POINT ARE NORTH 1,010,469.63, EAST 1,801,547.52.

INITIAL POINT

FROM THE POINT OF COMMENCEMENT, I TRAVEL SOUTH
89°22' 41" EAST ALONG THE SUBDIVISION LINE COMMON TO
SECTIONS 14 AND 23 FOR 2105.44 FEET TO THE WEST
BOUNDARY OF THE FUTURE LOTS OF CROOKED RIVER RANCH
NO. 16, A COMMERCIAL PLAT, WHERE I BURY A
CONCRETE MONUMENT AFFIXED WITH A 3 - INCH DIAMETER
BRASS CAP MARKED "INITIAL POINT CRR 16 6/79 ARK 1233",

SIX (6) INCHES BELOW GROUND SURFACE AS THE INITIAL POINT OF THIS SURVEY. I RAISE A MOUND OF ROCK AROUND AND OVER THIS POINT AND SET A I * 4 * 36 INCH WITNESS STAKE. COORDINATES OF THIS POINT ARE NORTH 1,010,466.77, EAST 1,803,652.83.

- I THEN TRAVEL SOUTH 89°41'37" EAST ALONG THE SUBDIVISION
 LINE COMMON TO SECTIONS 13 AND 24 FOR 1320.89 FEET TO THE
 EAST BOUNDARY OF SAID CROOKED RIVER RANCH NO. 16.
- I CONTINUED ALONG SAID SUBDIVISION LINE FOR 1320.89 FEET TO THE ONE-QUARTER CORNER COMMON TO SAID SECTIONS 13 AND 24, SET BY SINGLE PROPORTIONATE DISTANCE AS DESCRIBED IN THE SURVEY OF CROOKED RIVER RANCH NO. 15, AS DESCRIBED IN VOLUME A OF PLAT CABINET, PAGES 108A 110A, RECORDS OF THE CLERK OF JEFFERSON COUNTY, OREGON. THIS POINT 15 INACCESSIBLE, FALLING IN THE CANYON OF THE CROOKED RIVER. (I SEARCH FOR AND FAIL TO FIND ANY EVIDENCE OF THE WITNESS CORNER DESCRIBED BY THE SURVEYOR GENERAL. I ALSO DO NOT SET ANY REFERENCE AT THIS POINT WHICH IS PROPORTIONED TO LIE 2806.89 FEET NORTH 83°41'37" WEST FROM THE SOUTHEAST CORNER OF SAID SECTION 13 ON THE TOWNSHIP LINE.)
- I CONTINUE SOUTH 89°41'37" EAST ALONG SAID SUBDIVISION
 LINE FROM THE PROPORTIONAL POSITION OF THE ONE-QUARTER
 CORNER FOR 2989.83 FEET TO A STANDARD CONCRETE MONUMENT
 MARKING THE CORNER ON THE RANGE LINE COMMON TO
 SECTIONS 13 AND 24, TOWNSHIP 13 SOUTH, RANGE 12 EAST.
- I THEN TRAVEL NORTH 0°30'IZ" EAST ALONG THE RANGE LINE
 BETWEEN RANGES IZ EAST AND I3 EAST FOR 2729.83 FEET TO
 THE EAST ONE-QUARTER CORNER OF SECTION I3, TOWNSHIP I3
 SOUTH, RANGE IZ EAST, WHICH IS A SCRIBED STONE WITH
 TWO BEARING TREES. I REMOVE THIS STONE AND SET
 A STANDARD CONGRETE MONUMENT.
- I THEN TRAVEL NORTH 0°49'19" EAST ALONG SAID RANGE
 LINE FOR 1634. 97 FEET TO THE CORNER COMMON TO SECTIONS

 DESCRIBED BY THE SURVEYOR GENERAL. I REMOVE THIS
 STONE AND SET A STANDARD CONCRETE MONUMENT.
- I THEN TRAVEL NORTH FOR 16.65 CHAINS (GLO) AND SEARCH FOR AND FAIL TO FIND ANY EVIDENCE OF THE CORNER COMMON TO SECTIONS 12 AND 13, TOWNSHIP 13 SOUTH, RANGE 12 EAST (NORTHEAST CORNER, SECTION 13).
- I THEN TRAVEL WESTERLY FOR APPROXIMATELY 41.54 CHAINS
 (GLO DISTANCE) TO AN "X" SCRIBED UPON A 36 x 36 x 24 INCH
 HIGH BOULDER MARKING THE SOUTH ONE QUARTER CORNER
 OF SECTION 12, TOWNSHIP 13 SOUTH, RANGE 12 EAST, AS
 DESCRIBED BY THE SURVEYOR GENERAL.
- I SEARCH FOR AND FAIL TO FIND ANY EVIDENCE OF THE NORTH ONE-QUARTER CORNER TO SECTION 13 AT THE SURVEYOR GENERAL'S CALL OF 3.82 CHAINS WEST OF THIS POINT.
- I THEN TRAVEL NORTH 89°24'24" WEST FOR 2887.37 FEET ALONG
 THE SUBDIVISION LINE COMMON TO SECTIONS 12 AND 13 AND
 A PORTION OF SECTION II, TO A BRASS CAP SCRIBED
 "TENNYSON ENGINEERING " AS DESCRIBED IN THE SURVEY OF
 CROOKED RIVER RANCH NO. 14, MARKING THE CLOSING CORNER
 TO SECTIONS 13 AND 14 (NORTHWEST CORNER OF SECTION 13).
- I CALCULATE BY SINGLE PROPORTIONATE MEASUREMENT, THE NORTH ONE QUARTER CORNER OF SECTION 13 TO BE

CROOKED RIVER RANCH NO.16 JEFFERSON COUNTY, OREGON. SHEET LOF 10

SITUATED 2635.66 FEET SOUTH 89°24'24" EAST OF THIS CLOSING CORNER.

- I THEN TRAVEL SOUTH 0°37'32" WEST ALONG THE SUBDIVISION LINE COMMON TO SECTIONS 13 AND 14 FOR 2743.15 FEET TO A ONE (1) INCH IRON PIPE MARKING THE EAST ONE QUARTER CORNER OF SECTION 14.
- IN RESEARCHING THE RECORDS OF THE SURVEYOR GENERAL OF THE GENERAL LAND OFFICE, I FIND THAT THE WEST ONE-QUARTER CORNER OF SECTION 13 WAS NEVER SET BY THE GLO.

 I THEREFORE CALCULATE BY SINGLE PROPORTIONATE MEASUREMENT ITS POSITION TO BE 96.08 FEET, SOUTH 0°25'38" WEST ALONG THE SUBDIVISION FROM SAID EAST ONE-QUARTER CORNER OF SECTION 14. AT THIS POINT I SET A STANDARD CONCRETE MONUMENT.
- I THEN TRAVEL SOUTH 0°25'38" WEST ALONG THE SUBDIVISION LINE COMMON TO SECTIONS 13 AND 14 FOR 2746.64 FEET TO SAID CORNER COMMON TO SECTIONS 13, 14, 23 AND 24, THEREBY COMPLETING THE RETRACEMENT OF SECTION 13, TOWNSHIP 13 SOUTH, RANGE 12 EAST, WILLAMETTE MERIDIAN.






SANITATION RESTRICTIONS
